

Responsive to the Official Action of March 8, 1970, please amend the above entitled application as follows:-

In the application wherein the term "glassware" is used to identify the goods please change as follows: glassware, namely tableware, vases, bowls and pitchers -

The citations listed in the action have been duly noted and in the instance of Registration # 500,666 and notwithstanding the fact that the goods were classified for registration in Class 33 "Glassware", the fact remains that the goods of applicant are dissimilar and therefor the class should be split in view of the diversity of the goods and type of businesses involved.

With reference to applicant's mark, the character or style employed for the letter plus the bar beneath the letter N enclosed in a circle distinguishes the mark from the marks of the prior registrants to a degree that no confusion is caused such as would resemble the marks of the prior registrants, deceive or bring about a mistake in judgment in the selection of goods desired.

Aside from the above, the main reason for the filing of the application by the American Carnival Glass Association, Inc., was to maintain the quality and standard of the original Northwood Glass products which has been them.

by cheap imitations and as such extenuating circumstances have resulted and which should be considered a mitigating factor to be weighed in the equation before a final decision is rendered by the Examiner.

Reconsideration is therefor requested for the reasons stated and a favorable opinion is solicited.







Dear Mr. McCaslin:

Mrs. Carlton Schleede has informed us that you are the new President of American Carnival Glass Association, Inc. and that anything pertaining to your trademark registration should be addressed to you. If you are not aware, the trademark law requires that a declaration of current use of a registered trademark must be filed between five and six years after the date of registration of the same. If such a declaration is not filed, the registration will be canceled. In addition, the law provides that if a second declaration is filed alleging that there is no controversy relative to the ownership of the trademark and that the mark has been in continuous use for five consecutive years, the registration will become incontestable.

We suggest that in connection with the above mark we file a declaration of current use and, if possible, a combined declaration satisfying all the above requirements. In this connection, we will need the following information:

- 1. Is the mark still in use in interstate commerce?
- 2. Has the mark been in substantially continuous use for the past five years? Generally, some use of the mark in

each of the past five years would satisfy this requirement.

- 3. Our records show that the mark is used by applying it to labels affixed to the goods and by applying it to the containers for the goods. Has there been any change in the nature of the goods?
- 4. The registration was obtained in the name of American Carnival Glass Association, Inc. Has there been any change in the name of the owner or the ownership of the mark?

If you wish us to prepare and file either of the above declarations, please let us know and please let us have your answers to the above questions. Please send us two specimens showing the mark as currently used.

Please let us know if you have any questions in connection with this matter.
